The app is available for Apple iOS and Android. Your client will need to **download** HSBC Life Online Health Services from their app store.

They will also need to **register** for our policy portal HSBC Access (if not already registered) by following the on-screen prompts.

A textphone service is also available for customers with hearing and/or speech impairments.

Second Medical Opinion

A consultation only a call away. By using the 24/7 Remote GP Consultation service your client can talk to a UK-based doctor about any health or medical concerns by videocall or phone.



An easier way to get a prescription. As part of your client's Remote GP Consultation appointment they can also get a private prescription without needing to visit a clinic.


- ✓ No charge for prescription itself and doctor will outline medicine cost before prescribing

Physiotherapy
